Exclusion Criteria: Patients with chronic tonsillitis, Patient with any other systemic illness, Patient with Ca tonsils and patients with tonsillitis who needed tonsillectomy. Withdrawal Criteria: Case without proper follow-up., Patient did not come at regular interval for follow-up., Patient did not take medicines properly.

Sampling Technique: Simple Random

Treatment Intervention:


- Data analysis: Every patient included in the study was interrogated in detail and the history and examination findings are recorded in the case record. In all cases, a detailed analysis and evaluation were done for erecting the totality. The miasmatic basis of the symptoms was also considered to understand the miasmatic influence in each case.
- Approach: Non-Repertorial as well as Repertorial
- Remedy Selection: If Repertorial approach will taken then Selection of medicine will make after considering the reportorial analysis and further differentiation with Materia Medica. If Non-repertorial approach will taken Then Selection of medicine will made after completely going through materia medica.
- Potency selection will be in regards to posology.

Auxiliary Management: Patients were given instructions regarding diet and regimen. They were advised to avoid cold food and drinks, cold exposure, to do hot salty gargling. Follow-Up Criteria:


- Potency selection depends on individual susceptibility.



## Fig.1. Distribution of Cases According To Age:




### Fig.2. Distribution of Cases According to SEX:







# Fig 3. Distribution Of Cases According to treatment by acute medicine










# Fig 6. Distribution of cases according to Brodsky scale (After treatment)

**Fig 7.** Distribution of cases according to VAS scale (Before treatment)





Fig 8. Distribution of cases according to the Prescribed potency of medicine



**Conclusion:** Among 30 cases of Tonsillitis, Belladonna is regarded as mostly selected acute medicine in acute tonsillitis because Belladonna is an acute and short acting medicine and its peculiar affinity towards tonsil affections help in achieving cure in patient and It gives improved results in given cases.

Although such cases with characteristic symptoms required medicines other than Belladonna such as Lachesis, Hepar sulph, Sulphar, Baryta carb, Calcarea carb, Calcarea flour, Natrum mur, Carcinosin, Merc sol. According to my study, Acute Tonsillitis is commonly affected among young adults between 18-39 years of age. It is commonly affected in female (18 cases) among These 30 cases.

In 15 cases of tonsillitis, we prescribed these acute medicines in 30C potency and remaining 15 cases required 200C potency according to the susceptibility criteria of patient. We prescribed medicine mostly based on the characteristics acute totality of patients which give immense results in most of the cases. Hence, we get to know about instant results of acute homoeopathic medicines in cases of acute tonsillitis very precisely.

This is the best way to study the homoeopathic approach in acute tonsillitis.
